List of the certificates/documents required for verification and admission for the applicants who have already completed bachelor. The applicants must appear in person at KUSOM with original and one set of copies of all required certificates/documents as follows:

- 1. Mark sheet, Character Certificate of Grade 10 / SEE or equivalent
- 2. Transcript, Provisional Certificate, Character Certificate of +2 or equivalent
- 3. Transcript, Provisional Certificate, Character Certificate of bachelor or equivalent
- 4. Original Migration Certificate of bachelor or equivalent
- 5. Citizenship Certificate
- 6. Five recent pp size Photo
- 7. Job Experience Letter.

Eligibility criteria

Nepali and Non-Nepali nationals with three-year work experience and Bachelor degree of at least two-year duration in any discipline with 45 percent in aggregate or CGPA 2.0 on a scale of 4 or Master degree in any discipline with 45 percent in aggregate or CGPA 2.0 on a scale of 4.

OR

Six years of work experience and a Bachelor Degree or equivalent of at least two-year duration in any discipline with a minimum of 40 percent in aggregate or CGPA 2.0 on a scale of 4 from universities recognized by Kathmandu University.
