List of the certificates/documents required for verification and admission for the applicants who have already completed bachelor. The applicants must appear in person at KUSOM with original and one set of copies of all required certificates/documents as follows:

- 1. Mark sheet, Character Certificate of Grade 10 / SEE or equivalent
 - 2. Transcript, Provisional Certificate, Character Certificate of +2 or equivalent
 - 3. Transcript, Provisional Certificate, Character Certificate of bachelor or equivalent
 - 4. Original Migration Certificate of bachelor or equivalent
 - 5. Citizenship Certificate
 - 6. Five recent pp size Photo

The applicants who are seeking admission on the provisional basis i.e. who have only completed bachelor final year/semester exam are required to verify the following original documents before the payment of admission fee.

- 1. Mark sheet, Character Certificate of Grade 10 / SEE or equivalent
- 2. Transcript of plus 2 and Character Certificate
- 3. Admit card of final year/semester exam
- 4. Citizenship Certificate
- 5. Five recent pp size Photo

Applicants to be admitted on the provisional basis must meet the minimum required eligibility criteria as below once the bachelor level result is published; failing which the admission will be automatically annulled.

Eligibility criteria

Nepali and Non-Nepali nationals with a Bachelor's Degree of at least three years' duration or equivalent degree in any discipline with a minimum of 50 percent in aggregate or 2.0 CGPA on a scale of 4 from universities recognized by Kathmandu University.

Note: An undergraduate student who has completed the qualifying educational level but is waiting the final result may apply on provisional basis, provided he/she has already appeared in the last semester or final annual examination of the program and passed all previous year/semester courses with required minimum grade/percent.

- A candidate willing to withdraw the admission will be allowed to do so only within 15 days of the admission, and will be refunded only 70% of tuition and other fees, and only 50% of the caution money.
